#### *Romania Secondary Education Project*

1. The *Government of Romania* has received financing from the World Bank toward the cost of the Romania Secondary Education Project, and intends to apply part of the proceeds toward payments under the contract for *Dissemination - Printing and materials*.
2. The Ministry of Education – Unit for the Management of Externally Financed Projects now invites sealed bids from eligible bidders for: *Dissemination - Printing and materials* (services for printing and delivery of guidelines).
3. Bidding will be conducted through the National Competitive Bidding (NCB) procedure as specified in the World Bank’s *Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers, January 2011, Revised July 2014* (“Procurement Guidelines”), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank’s policy on conflict of interest. The evaluation will be done for the entire contract. Details, including qualification requirements, are provided in the Bidding Documents.

The documents will be released on the basis of a written confirmation that all postage costs will be covered by the interested bidder. Interested bidders may also receive bidding documents by e-mail. However, in case of discrepancy the hard copy will prevail.
6. Bids must be delivered to the address below on or before **May 23<sup>th</sup>, 2023 at 11:00 AM Bucharest local time**. Electronic bidding will not be permitted. Late bids will be rejected. Bids will be publicly opened in the presence of the bidders’ designated representatives and anyone who choose to attend at the address below on **May 23<sup>th</sup>, 2023 at 11:00 AM Bucharest local time**.

7. All bids must be accompanied by a **Bid Security** in the form described in the Bidding Documents.
