Dear Sirs,

Regarding the International Competitive Bidding for **Procurement of Packages of digital equipment for online learning in ROSE supported high-schools – Interactive boards**, the following clarifications must be taken into consideration when preparing your bid:

Inquiry 1: “Similar experience - In the procurement documents, point 3. Qualification (ITB 36), 3.1 Post qualification Requirements (ITB 36.1)

If Bidder is not manufacturer:

If a Bidder is not a manufacturer, but is offering the Goods on behalf of the Manufacturer under Manufacturer's Authorization Form (Section IV, Bidding Forms), the Manufacturer shall demonstrate the above qualifications (i), (ii), (iii) and the Bidder shall demonstrate that it has successfully completed at least 2(two) contracts of similar goods in the past 3 (three) years (2017-2019) with value of not less than 1 million USD each.

Do you accept bidders with similar experience in contract for the mentioned value with the following CPV codes:

Main CPV: 38000000-5 – Echipamente de laborator, optice si de precizie (cu exceptia ochelarilor) (Rev 2)

Secondary CPV: 34000000-7 – Echipament de transport si produse auxiliar pentru transport (Rev 2)”

Clarification 1: *If a Bidder is not a manufacturer but is offering the Goods on behalf of the Manufacturer under Manufacturer's Authorization the Bidder shall demonstrate that it has successfully completed at least 2(two) contracts of **similar goods** in the past 3 (three) years (2017-2019) with value of not less than 1 million USD each.*

The above-mentioned CPV codes, are not accepted as similar goods.

Inquiry 2: “Regarding point 5. Eligible Goods and related Services,

5.3

For purposes of this Clause, the term “goods” includes commodities, raw material, machinery, equipment, and industrial plants; and “related services” includes services such as insurance, installation, training, and initial maintenance.

The beneficiary want the bidder to assure the installation and commissioning of all the equipment or just one product at every location?



For example, there are 2 locations at ISJ Ilfov with 74 equipment – the bidder must deliver 74 pieces and install one equipment, and the rest of 73 pieces will be installed by the Beneficiary?

The above question is based on the following paragraph:

5. Inspections and Tests

The following inspections and tests shall be performed: The receiving note to be signed by the County School Inspectorates / Bucharest School Inspectorate representatives will contain detailed description of goods and shall be in Romanian language. A test of sample will be conducted for one interactive board from each project site. Only after such test the acceptance certificate will be signed.”

Clarification 2: *A test of sample will be conducted for one interactive board from each project site. Only after such test the acceptance certificate will be signed. The Inspections and tests shall be conducted at: the 41 County School Inspectorates (ISJ) and Bucharest School Inspectorate (ISMB) depending on the County in which the beneficiary high school is located and per the list in Section VII. Schedule of Requirements.*

No installation and training of personnel in schools is required.
